In addition, she leads a team that conducts the University's annual greenhouse gas inventory and produces biannual updates to the CSU Climate Action Plan. Every three years, she is part of team that generates the Sustainability Tracking, Assessment & Rating System (STARS) submission, administered by the Association for Advancement of Sustainability in Higher Education (AASHE), that rates the university on their triple bottom line sustainability performance. Historically, CSU has been one of the highest performers in the STARS rating system.

I live in southwest Loveland with my husband and children.


MITZI MCCOY | Deputy Town Manager, Johnstown
