
**DEB DEBOUTEZ** | Greeley City Councilmember, City of Greeley

Mark has been married to Neyla (a CSU graduate) for 48 years. The couple have three grown children and five grandchildren.




JULIE DUBIN | Executive Director, Peaks to People Water Fund
