# **BRENT BARTLETT, Esq.** | Partner, Fischer, Brown, Bartlett, Larsen, and Irby, P.C.

Mr. Bartlett is a native of Colorado. He has extensive experience in complex transactions involving land, water, and business interests. Mr. Brown has also participated for over 20 years on Colorado Water Congress State Affairs Committee, and in this capacity has worked on water related legislation. He also received a Bachelor of Science in Economics from the University of Colorado at Boulder in 1990, and his Masters of Science in Applied Economics, with an emphasis in Natural Resources, from Montana State University in 1994.

## JEAN LEVER | Thompson River Commissioner, Colorado Division of Water Resources

Jean serves as the Big Thompson River Commissioner in District 4. Jean is responsible for the river's daily water distributions and maintaining water diversion records. Jean's work involves setting calls on the river, assuring diversions are in priority, assuring augmentation and return flows requirements are met, and compliance of decrees.

#### MICHAEL HEIN | Assistant Division Engineer, Water Division 1

Michael was born and raised in northern Colorado. He received a B.S. in Civil Engineering from Colorado State University in 1998 and joined the Colorado Division of Water Resources in 2007. For the first four years he held the Groundwater Engineer position in the Division 1 Greeley office before becoming an Assistant Division Engineer in 2010 where he held that position for over eight years. Mr. Hein was appointed as the Lead Assistant Division Engineer for Water Division 1 in September of 2018. As the Lead Assistant Division Engineer, Michael assists the Division Engineer in all matters related to water administration in Water Division 1 including ground and surface water, and compliance with the South Platte River Compact, Sand Creek Memorandum of Agreement between the states of Colorado and Wyoming and Sand Creek water users, and the Wyoming v. Colorado Supreme Court decision for the Laramie River and its tributaries.

#### JENI ARNDT | Mayor, City of Fort Collins

## JENNIFER GIMBEL | Retired, Senior Water Policy Scholar, Colorado Water Center

Jennifer Gimbel has a Juris Doctor from the University of Wyoming, a master's degree in mathematics from the University of Delaware and a bachelor's degree from the University of Wyoming. She most recently was the senior water policy scholar for the Colorado Water Center, based at Colorado State University. In this position she taught graduate and undergraduates interested in water policy issues and developed published articles on the Colorado River and water issues facing Colorado.

She served as the principal deputy assistant secretary for water and science in the Department of the Interior and was deputy commissioner for external and intergovernmental affairs for the Bureau of Reclamation.

From 2008 to 2013, Gimbel was the director of the Colorado Water Conservation Board, a group within the Department of Natural Resources that works to protect and develop the state's water resources. As a water lawyer, she worked for the Attorney General's Offices in Wyoming and Colorado.

In August 2022, Gimbel was presented as the 2022 winner of the Aspinall Award by the Colorado Water Congress during its summer convention. She also became a Terry J. Stevenson Scholar for the Common Sense Institute and co-authored the study: Adapting Colorado's Water Systems for a 21<sup>st</sup> Century Economy and Water Supply.
